Sources of Data

The following sources of data were utilized in developing this report

- Student performance on the Counselor Preparation Comprehensive Examination (CPCE)
- Student performance on final internship ratings from instructors and site supervisors
- Alumni surveys
- Site-supervisor surveys
- Alumni employer survey
- Admissions, enrollment, and graduation data
- Faculty observations and discussions during periodic faculty meetings held bi-weekly, systematic student assessment meetings held toward the end of each fall and spring semester, and the annual planning retreat held at the end of each summer semester.

Objective 1

scored at least an average of 4 in each of the three content areas. The mean score for all students on the full evaluation was 4.79 with a standard deviation of .38.

The data for the three content areas of Supervision Dispositions, Counseling Dispositions, and Counseling Skills are highlighted below.

Objective 4: Students will demonstrate the professional and personal aptitude and behavior required for effective clinical mental health counselors, as specified in and measured by the UNG Professional Performance Review (PPR) form.

Professional Performance Reviews are completed at the end of each semester in order to evaluate non-academic characteristics needed to develop therapeutic relationships and make ethical decisions. Faculty have determined that a score of 3 (out of a possible 5) for each of the 10 criteria meets expectations for their professional development stage. Therefore, the measure is that 100% of students will score at least 30 on the final PPR, which will take place in the semester prior to graduation. For the 2021 graduates, 100% (N=12) of students scored at least 30 on the final PPR. Mean ratings are highlighted below.
